# **Understanding Immigration Court**

**ICE Check In:** an appointment for ICE to make sure you are still in the region and not getting in legal trouble. Appointment may be in person or by phone or email.

Call ICE if you have questions.

**Notice to Appear** or **Notice of Hearing:** states time and place for your next immigration court date. You <u>must</u> attend.

In absentia deportation: if you fail to go to court, you can be ordered deported in your absence.

**Right to hire a lawyer:** Immigration court allows you a lawyer but not a public defender. If you cannot find a lawyer before your hearing, save records of trying, give them to the judge, and ask for more time.

**Decision of the Immigration Judge:** may happen at a hearing or through mail. You will <u>not</u> be immediately deported even if a decision is negative. If it is negative you will have 30 days to appeal to the Board of Immigration Appeals. If you appeal, you will not be deported until the Board decides your appeal.

**Order of Supervision:** if the judge orders deportation, ICE may agree not to deport you right away but give you ICE check-in dates. This is called an order of supervision. It makes you eligible for a work permit.

# Legal Orientation Program at Immigration Court

You have the right to defend yourself against deportation. If you are afraid of returning to your country or have a family member in the U.S. you may have a strong defense. To learn more, visit the Legal Orientation Program at the Immigration Court. This is run by Catholic Charities, a very respected organization. They can explain what to expect in court and how to defend yourself.
