A message from our parish finance council:

The finance council meets quarterly with Father Neil and parish staff to approve the annual operating budget, review actual results compared to budget, and to advise on major capital expenditures. Operating revenues were up 2.2% from FY23 to FY24, driven by an increase in the weekly collections. Operating expenses were up 13.4% due to add'l investment in the religious education program, higher insurance costs, and other general inflationary pressures. The parish also realized several extraordinary expenses in FY24 related to the installation of a new handicap accessible door in the Church, improvements to the parish center lighting and heating, and a tree removal. In July the finance council approved a new parish budget, with break-even operations projected for FY25 (Jul24-Jun25).

**Note that Immaculate Conception cemetery savings and financials are kept separate from the parish financials above. Cemetery financials include proceeds from the sale of lots as well as internment fees. These are used to offset costs such as cemetery maintenance. A perpetual care savings account also exists, the principal on which is restricted. By rule, only interest from the perpetual care account can be used to offset current maintenance costs. Cemetery reports are reviewed by the parish finance council. In FY24, the cemetery ran a slight surplus, with all earnings sent directly to cemetery savings.
