The Parish Finance Council would like to thank all the parishioners in the Whaling City Catholic Community for supporting our Collaborative. We are happy to report we have been able to make extensive repairs and updates at all 3 of our parishes. Some things to note:

St. Francis: The large net operation deficit was due to less money being collected in collections and some extraordinary repairs needed. The roof 50% completion payment was made in Aug 23. We installed a new, donated, sound system and had to pay for the cost of installation. Heating costs, snow removal and maintenance of the church grounds also increased this year.

Holy Name: The large net operation deficit was due to extraordinary expenses, primarily for the kitchen project at the parish center. The parish collections did very well this year. We were able to pay for the 50% deposit for the kitchen renovation, replace exterior lighting at the hall, replace the swell box in the organ and Resonant Energy began working on solar panels. Gas, electric and insurance costs also increased this year. The solar project, once completed, will save us money on energy bills and provide reimbursement over time. We were also able to purchase everything needed for the Square point of sale system that we use at the craft fair.

St. Lawrence: The large net operation deficit was due to less money being collected in collections as well as large expenses for repairs needed. Snow removal and maintenance of the church grounds, gas and electric increased this year. Boiler flooding issues and the faucet in the church sacristy were repaired. The food pantry needed mold remediation services to provide a safe environment for the food pantry. Organ repairs due to a problem with a connection after a transformer had been replaced also needed to be taken care of. Bluestone was removed due to it being a trip hazard and was replaced by poured concrete in the church parking lot.

Across all 3 parishes we have applied and are awaiting money from the Employee Retention Tax Credit program. We saved by switching to a new envelope provider and have implemented a new online donation platform that allows online recurring donations in the hope that it will help increase our giving across the Collaborative.

Your support remains paramount.
