The Parish Finance Council would like to sincerely thank all the parishioners in the Whaling City Catholic Community for supporting our Collaborative. We are happy to report we have been able to make extensive repairs and updates to both parishes. Some things to note:

St. Lawrence:

We have utilized the donations from the restoration of the church for the following: the clock tower restoration, repairing the steps that leads to the clock tower, the interior painting and plaster work of the church, emergency repairs and protective glass addition to the inside of the church in order to preserve the fresh paint and plasterwork done. The organ was tuned, cleaned, and extensive maintenance was done. However, please note the profit and loss statement does not reflect the total cost of the restoration project as this will be depreciated over time. The total cost as of June 30, 2025 for these projects were \$409, 667.58. Looking into the future, we will need to replace the boiler of the church, and will be utilizing the depository money that came from St. Francis to be able to do this. There are still North and South side windows that need to be restored and will be added to our current Chancery Loan.

Holy Name:

The Holy Name Parish Center had a full kitchen renovation, the total cost of this project was \$313,069.38 and is not represented on the profit and loss statement as it will be depreciated over time. Another project done was the outdoor lights in the parking lot, and energy saving bulbs installed. The handicap door in the parish center was installed with the generosity of the Women's Guild. Lastly, asbestos was removed from the floor tiles.

In both parishes, we are looking into consolidating internet and phone bills that will reduce our yearly contract services. There are still some employee retention credits from the IRS that we are awaiting this upcoming year and are looking into other services we may be able to cut back on to reduce our yearly expenses.
