A message from our parish finance council:

The finance council meets quarterly with Father Neil and parish staff to approve the annual operating budget, review actual results compared to budget, and to advise on major capital expenditures. Operating revenues were up 12.4% from FY24 to FY25, driven by an increase in the weekly collections. Operating expenses were up 17.7% due to add'l investment in the religious education and youth programs, higher insurance costs, and other general inflationary pressures. There were several extraordinary revenue and expense items which we have segregated from parish operating income in the numbers above. Immaculate Conception was able to access funds from the federal government's employee retention credit program, creating a one-time benefit for the parish. Conversely, repairs to the church roof, parish center heating, and completion of the handicap door project, were among several exraordinary expenses incurred in FY25.

^{**}Note that Immaculate Conception cemetery savings and financials are separate from the parish financials above. Cemetery financials include proceeds from the sale of lots as well as internment fees. These are used to offset costs such as cemetery maintenance. A perpetual care savings account also exists, the principal on which is restricted. By rule, only interest from the perpetual care account can be used to offset current maintenance costs. In FY25 the parish transitioned administrative and financial responsibility for cemetery operations to the Diocesan Cemeteries Office.
